AGENDA ITEM:

Adopt resolution OB 20- to formally dissolve the County Oversight Board to the City of Colusa Redevelopment Successor Agency.

REQUESTED ACTION:

Staff recommends that the County Oversight Board of the City of Colusa Redevelopment Agency direct the County Oversight Board to adopt Resolution OB 20-, to formally dissolve the County Oversight Board and Successor Agency to the City of Colusa Redevelopment Agency.

BACKGROUND:

Under redevelopment law, HSC section 34187(c) states that if a former redevelopment agency (RDA) was not allocated property tax revenue prior to February 1st, 2012, the Agency shall, no later than November 1st, 2015 submit to the Oversight Board (OB) a request to formally dissolve the Agency.

The City Redevelopment Agency effective date was June 2, 2011 and the first taxing increment should have been received in fiscal year 2012-13; however, the Project Area did not have positive incremental value; therefore, did not receive property tax revenue prior to February 1st, 2012. The information has been confirmed by the City's tax consultant HdL Coren & Cone.

Based on HSC section 34187(c), the Oversight Board and Successor Agency is required to dissolve.

BUDGET IMPACT:

City of Colusa Redevelopment Agency remaining loan balance of \$116,044 will revert back to the City of Colusa General Fund as a FY 2019-20 additional expenditure.

OB RESOLUTION 20-01

A RESOLUTION OF THE COUNTY OVERSIGHT BOARD FOR THE CITY OF COLUSA SUCCESSOR AGENCY FORMALLY DISSOLVING THE SUCCESSOR AGENCY PURSUANT TO HEALTH AND SAFETY CODE SECTION 34187 (b)

WHEREAS, ABx1 26 was enacted in June 2011 which dissolved all redevelopment agencies operating within the State of California and authorizing the formation of a successor agency to the former redeveloper agency for the purpose of winding down the affairs of the former redevelopment agency; and

WHEREAS, the City of Colusa City Council opted to form the Successor Agency to the City of Colusa Redeveloper Agency whose primary purpose was to fully repay and retire all debt of the former redevelopment agency; fully perform, assign, or terminate all contracts and other obligations of the former redevelopment agency; fully dispose of all remaining assets of the former redevelopment agency; and remit to the County Auditor-Controller, for distribution to the affected taxing entities, all remaining funds in the possession of the Successor Agency; and

WHEREAS, the Successor Agency received written confirmation from the State of California Department of Finance ("DOF") issuing a finding that the Successor Agency Last and Final ROPS was not approved and based on HSC section 34187(c) requirements the Successor Agency should formally dissolve; and

WHEREAS, HSC section 34187(c) states that if a former redevelopment agency (RDA) was not allocated property tax revenue prior to February 1st, 2012, the Agency shall, no later than November 1st, 2015 submit to the Oversight Board (OB) a request to formally dissolve the Agency; and

WHEREAS, currently, the loan from the City of Colusa General Fund to the City of Colusa Redevelopment Agency for start-up costs has a remaining outstanding balance estimated at \$116,044; and

NOW THEREFORE, BE IT HEREBY RESOLVED by the governing board of the Oversight Board to the Colusa Redevelopment Successor Agency does hereby resolve as follows:

Section 1. Recitals.

The foregoing recitals are true and correct and made a part of this Resolution.

Section 2. <u>Dissolution of Successor Agency</u>

The City Council of the City of Colusa, in its capacity as governing board of the Successor Agency to the City of Colusa Redevelopment Agency, hereby approves, ratifies and confirms all actions by the County Oversight Board staff to terminate the Oversight Board and Successor Agency to the City of Colusa Redevelopment Agency.

Section 3. <u>Direction to Executive Director.</u>

The Executive Director or his/her designee is authorized and directed to take all actions necessary to implement this Resolution, including without limitation.

Section 4. Severability.

Declares that if any provision, sentence, clause, section or part of this Resolution is found to be unconstitutional, illegal or invalid, such finding shall affect only such provision, sentence, clause, section or part, and shall not affect or impair any of the remaining parts.

Section 5. Effective Date.

This Resolution shall take effect immediately upon adoption.
